Thank you for another incredible year at the Greater Salina Community Foundation. Your generosity and commitment continues to inspire us and give us reason to reflect on who we are and where we are headed. As we prepare for our next 25 years, we are excited to introduce a revised mission— improve lives and enrich communities through endowed funds. Alongside this, our 2028 vision will guide us to impact today and transform tomorrow through trusted leadership, stewardship, and generosity.

This year, we saw our vision come to life in many meaningful ways. With good stewardship of our funds, our total assets have grown to \$318.9M, enabling us to awarding over \$25.1M in grants and scholarships throughout the region on behalf of our donors. In Saline County alone, \$13.5M was granted through donor advised funds and our competitive grant cycle to support initiatives like Prairieland Market's Building a Healthy Community campaign. Additionally, \$250.9K in scholarships helped 112 students pursue their educational goals.






GIVE BACK 5 SURPASSES GOAL!

We did it! The Give Back 5 campaign exceeded expecations, securing 133 pledges to support local nonprofits through legacy giving - surpassing the goal of 125 in one year.

People that took the pledge committed to donate at least 5% of their retirement or investment accounts to support local nonprofits by designating them as a charitable beneficiary. The pledges could go directly to the charity for immediate support, or to a fund at the Community Foundation

Engaging the Next Generation

When the Give Back 5 campaign launched, Luke and Teale Ryan knew they wanted to participate. It was the push they needed to begin estate planning. After meeting with their attorney, they decided to increase the percentage of their retirement assets designated for charitable giving—ensuring their pledge reflects 5% of their total estate.

They also want to model charitable giving—both time and financial—for their 12-year-old daughter, Sloane. "Having moved to Salina from the Washington DC area, it was difficult to see charitable donations in action in such a large city," said Teale. "Through GSCF's management of local funds and events like Match Madness, we've seen firsthand how our donations make a difference."

Teale and Sloane also volunteer every year at the Love, Chloe Foundation gala and donate to their fund at Match Madness. "We chose to include Love, Chloe Foundation in our pledge because all the money stays local to support families facing childhood cancer."

Improving Lives Through Local Foods: Prairieland Market

Prairieland Market has championed health and well-being in its mission to promote healthy food choices, nutrition education, and access to local, organic, and craft foods. Over the years, it has built a strong reputation of connecting local farmers, consumers, and food-insecure areas of the community.

Building a Healthy Community

Now, through its Building a Healthy Community capital campaign, Prairieland has taken a bold step forward, relocating to a newly constructed space at 118 S. Santa Fe Ave. right in the heart of downtown Salina. This move not only expands its reach but also contributes to the city's downtown revitalization, bringing fresh energy and purpose to the area.

"We chose to give to the campaign through our donor advised fund at the Foundation because we wanted to be a part of the growing momentum and improvement of downtown Salina," said Matt and Rita Shaffer. "Supporting access to high-quality, locally sourced, farm-to-market food through a downtown grocery store was incredibly appealing to us and adds yet another reason for our community to thrive."

The new location offers a full line of groceries, an expanded Community Supported Agriculture (CSA) program, increased storage and walk-in cooler capacity, and a commercial kitchen that prepares healthy meals using local ingredients. The kitchen also serves as a hub for educational programs, offering nutrition, cooking, and food preservation classes for all ages. It also offers WIC and SNAP benefits and donates CSA shares to the Salina Emergency Aid Food Bank ensuring greater access to healthy foods for everyone in the community.

Thanks to the generosity of private donors and local foundations, the campaign exceeded its original \$1 million goal—raising \$1.3 million."The community really embraced it and wants us to be successful," said Vickee Spicer, Executive Director. "Being in our new location puts us in front of more people, which results in more people having access to local healthy foods."

There is also a strong sense of community that sets Prairieland apart from larger grocery stores. "We know a lot of our customers by name. Many of them come in a couple times a week not only to grocery shop, but especially for the prepared foods because they know they can come in here and get something nutritious," said Spicer.

Teaching Life Skills

Prairieland Market's new home is more than a building—it's a symbol of community investment, collaboration, and a healthier future for everyone in the community. In collaboration with the Salina Emergency Aid Food Bank, Prairieland Market offers Life Skills Classes. These hands-on sessions help participants improve

Previously isolated at home, he found the classes to be a welcoming space where he could open up, share his cooking knowledge, and connect with others. The experience has helped him build social confidence, make new friends, and deepen his love for cooking. He's now volunteering at Prairieland Market, expanding his opportunities and staying engaged with the community.


A \$5,000 grant from the Fund for Greater Salina and Dane G. Hansen Community Grant Fund helped kick off the the First Annual Childhood Cancer Moms' Retreat was created to bring moms together who have or who are navigating a childhood cancer journey to foster connection, understanding, and lasting support among women who share a deeply personal experience.

A total of eleven moms attended the retreat, allowing for meaningful, intimate conversations and the ability to get acquainted more easily than with a large group. Among them, four had lost a child to cancer, four had children in remission, and three were supporting children currently in treatment or follow-up care.

"The moms' retreat provided a unique opportunity for childhood cancer moms to gather in a comfortable setting," said Heidi Feyerherm-Smith, Executive Director of Love, Chloe Foundation. "The moms were in all stages of the childhood cancer journeys and offered comfort and support to each other. 

Over \$24.6M was granted on behalf of our donors and regional affiliates in FY25. Of those dollars, \$13.5M was granted to Saline County nonprofit organizations, some recommended by donors through their funds and others determined by a local GSCF grants committee.

This year, the GSCF grants committee awarded \$227,821 to 39 organizations supporting 53 local projects through a competitive grant application process.

Honoring Faryl Lange's Legacy



Long-term Growth and Impact

Funds at the Community Foundation are invested for long-term growth with a goal to increase the fund balance and amount of grants awarded annually, while at the same time keeping the original gift intact.



This example is based on a 5% annual payout with a 1% administrative fee and a 10-year annualized 8.7% rate of return (as of 06/30/2025).

Fund Case Study: A Legacy of Giving: The Arlo R. Gruenthal Fund for the United Way

Established in December 2000 with an initial gift of \$2,000, the Arlo R. Gruenthal Fund for the United Way has become a lasting source of support for the Salina Area United Way. Over the years, the fund has grown to more than \$18,000 and has awarded over \$21,000 in annual grants—demonstrating the power of endowment-based philanthropy.

Arlo R. Gruenthal was a founding donor of the Greater Salina Community Foundation and understood the importance of long-term sustainability for local nonprofits. His vision and generosity continue to make a meaningful impact, ensuring that vital community services remain supported year after year.

The fund stands as a testament to Arlo's belief in building a better future through thoughtful giving. It also serves as an inspiring example of how even modest contributions can grow into powerful tools for change.








Impact Since Inception (By Area)
