## Give Back 5 Surpasses Goal!

The Greater Salina Community Foundation is proud to announce the successful completion of its Give Back 5 Community Giving pledge campaign. The Foundation surpassed its original one-year goal of 125 pledges with a total of 133 commitments to support local nonprofits through legacy giving.

The campaign invited individuals to pledge at least 5% of their retirement or investment assets to charitable causes in their communities after their liftetime. The results are nothing less than inspiring:

- 133 total pledges secured
- 58% of pledges came from next-generation donors (Gen X, Millennials, and Gen Z)
- 102 pledges resulted in the creation of permanent charitable funds
- 31 pledges are going directly to charities for immediate use

"I am truly blown away by the incredible response from our community," said Jessica Martin, President & Executive Director. "What I love most about the pledge list is its diversity—it includes people of all ages, backgrounds, and walks of life, making it a true reflection

of our community. The collective impact of these pledges lays a strong foundation for our nonprofits to continue their vital work for generations to come."

#### **Engaging the Next Generation**

When the Give Back 5 campaign launched, Luke and Teale Ryan knew they wanted to participate. It was the push they needed to begin estate planning. After meeting with their attorney, they decided to increase the percentage of their retirement assets designated for charitable giving—ensuring their pledge reflects 5% of their total estate. They also want to model charitable giving—both time and financial—for their 12-year-old daughter, Sloane. "Having moved to Salina from the Washington, D.C. area, it was difficult to see charitable donations in action in such a large city," said Teale. "Through GSCF's management of local funds and events like Match Madness, we've seen firsthand how our donations make a difference."

Teale and Sloane annually volunteer at the Love, Chloe Foundation gala and donate to their fund at Match Madness. "We chose to include Love, Chloe Foundation in our pledge because all the money stays local to support families facing childhood cancer."

#### **Creating a Strong Future**

The campaign was originally

launched by a local committee to inspire giving and build long-term resources for the next generation. They believe nonprofits are essential to the social, economic, and cultural well-being of our communities.

"The Give Back 5 community giving campaign is one of the most exciting and transformative things I've ever been involved in. The future impact on our community is astonishing," said Michael Chambers, VP of Community Impact. "Those that took the pledge have carved out 5 percent (or more) for the nonprofits that significantly improve the quality of life in our area. The generosity that I've seen throughout this campaign is inspiring and will strengthen our community forever!"

Personal connections to the work of nonprofits also inspired people like

Erica Chapel to take the pledge. "I know the value of nonprofits in our community and wanted to help contribute. Without donors, they wouldn't exist," said Erica. "I'm a Big with Big Brothers Big Sisters of Salina and deeply value the support they provide to children. When I was 8, I lost my brother and became an only child. I wish I could have had a Big to help me navigate life's challenges."

(\$3.4M in assets under management)



This option provides flexibility and customization, giving you the ability to tailor your investment strategy to your specific financial goals and risk tolerance. We currently partner with a network of 17 trusted advisors to manage 54 funds totaling \$40.8M.

n May 21st, we gathered in Salina at the Hilton Garden Inn to honor the achievements of our local scholarship recipients. With over 160 attendees, including 40 students and 22 generous donors and committee members, the annual Scholarship Banquet was a night of celebration and connection.

This special event offers a meaningful opportunity for donors to meet with the students who received their scholarship and for recipients to express their gratitude in person.

At the scholarship banquet, our donors witness the impact their scholarship has on student lives. What often begins as a desire to honor a loved one or inspire future generations evolves into a lasting legacy through the creation of a scholarship fund.

A highlight of the evening was guest speaker, Carrie Roe, a two-time recipient of the Hale Family Sunflower Promise Scholarship. Carrie shared how scholarships helped her succeed in college.

"Because of scholarships, I was able to focus on my schooling, participate in campus activities, and soak in everything my junior college and university had to offer," she said.

Carrie closed with this advice to students- "Figure out what you want to do, never forget your roots, don't be afraid to ask for help, and continue looking for scholarships." Her story is a powerful testament to the lasting impact of donor generosity.

## Foundations Team Up to Re-Fund Kansas STARBASE



aline County fifth graders were able to attend STARBASE Salina after spring break thanks to the generosity of grant dollars from the L.P. "Pat" Mullen Fund, GSCF donor advised fundholders, and a donor from the McPherson County Community Foundation. A total of \$55,000 of the \$100,000 needed was raised

to partially restore operations so that students could continue the program in a limited capacity. In addition to the monetary donations, several STARBASE staff on unpaid leave volunteered their time to teach because they believe in what the program does for the state of Kansas.

STARBASE is a Defense Department initiative that works to increase access to STEM education in school districts across the state. There are five host sites for Kansas STARBASE, each of which have dedicated equipment, teachers and classrooms designed for STEM education. Salina's STARBASE serves 14 counties and provides 25 hours of "hands-on, age-appropriate STEM

education to local schools."

"They get to see what a real engineer does," said Billie Jones, director of STARBASE Salina. "We do rocketry and chemistry lessons with students and focus on getting their hands on things as quickly as we can."

Students participated in engaging lessons on the Engineering Design Process, Newton's Laws of Motion, rocket building, and a chemistry experiment to determine if the reaction was endothermic or exothermic (email us at GSCF if you know what that means;)).

# Loyal, Passionate and Kind - John & Mary Quinley Setter smile fund



John and Mary Quinley recently established "A Better Smile Fund" at the Greater Salina Community Foundation, an endowed hardship field of interest fund that will help cover dental care costs for children who otherwise couldn't afford it. We had the opportunity to sit down with John to learn more about their connection to the Foundation and what inspired them to create a fund that will bring

healthy smiles to children for generations to come.

#### A Lifetime of Service and Generosity

John and Mary have always been generous with their time and money. John retired from Great Plains Manufacturing as the President of Land Pride Division, and Mary retired from Salina Regional Health Center having worked as a Nurse Administrator for many years. Their philanthropic journey in Salina spans decades. John has served twice as a fundraising chair for Salina Area United Way, and three terms on the GSCF board, including two years as Board Chair. Mary currently serves as chair for the Salina Regional Health Foundation board.

The Quinleys recently took the Give Back 5 pledge, committing to leave 5% of their retirement account to charity, but they also wanted to give while they live. "John and Mary exemplify the ideal community foundation relationship," said Michael Chambers, VP of Community Impact. "They have journeyed the full continuum of giving and transitioned from donors to various funds held at the Foundation to permanent endowed fund holders."

#### A Spark of Generosity

John said, "While growing up, there were unknown people in my life that contributed to my family's well-being in many ways; spiritually, emotionally, and financially." He made his first charitable donation at the age of 16, and that "lit a spark of generosity" that

has continued to grow over the years. The "real spark" for John, however, is revealed when he talks about his family, especially the joy of having both his children returning to Salina to raise families of their own. John shared that his lifelong goal has been to "give his kids the kind of childhood he wished he could have had." That perspective, shaped in part by the help his own family received, fuels his passion to help others, especially children.

#### Smiles that Last a Lifetime

The idea for "A Better Smile Fund" has been something that John and Mary have talked about for many years. "I didn't have a healthy smile growing up," said John. "If we can help kids who need help, it will be a wonderful thing for them as they grow into adults."

"It has been a privilege to assist John and Mary with this fund," said Jessica Martin, President & Executive Director of GSCF. "Having worked with John on our Board of Directors, I've seen firsthand his deep commitment to helping others—this fund is yet another example of that dedication."

A Better Smile Fund is one of the Foundation's newest permanently endowed funds. The principal is invested to grow over time, with annual distributions made to help children access the dental care they need. Through this fund, John and Mary are not only creating brighter smiles—they are building brighter futures for generations to come!

## Connecting with Our Community

They were asked about what they want to do with their 5%, and how they want it to make an impact. I found that the reasons for leaving a gift at the end of life are as varied and unique as the people taking the pledge.

Throughout the last 12 months a *new community* within our community has emerged. The community of Give Back 5 is something to truly behold. The group ranges in age from 25 to 94. Some are leaving a gift to a single charity and others are including multiple organizations in their list. Some are leaving gifts directly to charity and others are creating permanent endowed funds to support organizations forever.

The diversity of giving interest among the group is fascinating. Everyone I spoke with has a specific and unique reason for leaving something behind when they are gone. I'm thankful to be part of the Give Back 5 community and delighted to be able to say I took the pledge to leave something behind for the next generation. I have enjoyed the many opportunities to connect with people about why they choose to give so generously.

Even though we've met our goal of securing 125 pledges within the year, the Give Back 5 community is open to all. I hope you'll take the pledge too. Our team would love to connect with you and help you leave a legacy for our community.
